

## INVITATION FOR BIDS

Pursuant to Article 10 Item 6.1. of the Rules on Procedure for Procurement of Goods, Services and Works Assignment applied in Jadranski naftovod, Joint Stock Company,

2. Subject of bidding: **In-Line crack Inspection of Ø36" Pipeline Section Omišalj - Sisak, Fitness For Purpose – FFP**
3. The estimated purchase value: 597.252,64 EUR
4. JADRANSKI NAFTAVOD, dioničko društvo (JANAF Plc) is not obliged to conduct the procurement procedures according to the Public Procurement Act and the provisions of the Public Procurement Act do not apply to the procurement procedure concerned.
5. Bid shall be prepared in accordance with the Bidding Documents.
6. 7. Deadline for bids submission: **February 13, 2023 at 11,00 hours (local time).**
8. Address for submission of bids: Jadranski naftovod, dioničko društvo, Miramarska cesta 24, 10000 Zagreb (Croatia). Bids shall be submitted in a sealed envelope. The envelope shall contain the address of the Purchaser, the address of the Bidder and a reference: “Bid for Public Bidding No. 2022-0776 - In-Line crack Inspection of Ø36" Pipeline Section Omišalj - Sisak, Fitness For Purpose – FFP - DO NOT OPEN!”.
9. Date, time and place of bid opening: **February 13, 2023 at 11,00 hours** (local time), in the offices of Jadranski naftovod, dioničko društvo, Miramarska cesta 24, 10000 Zagreb (Croatia).
10. Bids not received until the specified time shall not be opened and shall be returned to the Bidders in unopened envelope.
11. The Bidder shall request the Bidding documents according to point 6 of this Invitation for bids, so that they may be included in the procedure.
12. Based on the criteria specified in the Bidding Documents, the Purchaser shall select the most favourable bid. The Purchaser retains the right to reject all bids and to invalidate the public bidding procedure respectively, without any obligation to compensate the Bidders for any costs or damages.
